**THE EDUCATION CITY (AMENDMENT) ACT, 2020**

**SINDH ACT NO. XIX OF 2020**

**AN  
ACT**

to amend the Education City Act, 2013.

WHEREAS it is expedient to amend the Education City Act, 2013, in Preamble.  
the manner hereinafter appearing;

It is hereby enacted as follows :-

1. (1) This Act may be called the Education City (Amendment) Act, 2020. Short title and commencement.
- (2) It shall come into force at once.
2. In the Education City Act, 2013, in section 3, for sub-section (2), the Amendment of section 2 of Sindh Act No.XVI of 2013.  
following shall be substituted: –
- “(2) The Board shall consist of –

- (x) Secretary to Government of Sindh, Land Utilization Department Member
- (xi) Secretary to Government of Sindh, Information, Science & Technology Department Member
- (xii) Secretary to Government of Sindh, Universities & Boards Department Member
- (xiii) Five persons to be appointed by the Chairperson having regard to the criteria prescribed in sub-section (2) of section 9 Member
- (xiv) Vice Chancellor or, as the case may be, a dean to be nominated by the Board. Member
- (xv) One person from the corporate or business sector to be nominated by the Board Member
- (xvi) A nominee of Higher Education Commission or its successor Member.” Member
