**THE SINDH BOARD OF TECHNICAL EDUCATION AND THE SINDH BOARDS OF
INTERMEDIATE AND SECONDARY EDUCATION (AMENDMENT) ACT, 2020**

**AN
ACT**

to amend the Sindh Board of Technical Education Ordinance, 1970 and the Sindh Boards of Intermediate and Secondary Education Ordinance, 1972.

WHEREAS it is expedient to amend the Sindh Board of Technical Education Ordinance, 1970 and the Boards of Intermediate and Secondary Education Ordinance, 1972, in the manner hereinafter appearing;

It is hereby enacted as follows:-

1.(1) This Act may be called the Sindh Board of Technical Education and the Sindh Boards of Intermediate and Secondary Education(Amendment) Act, 2020.

(2) It shall come into force at once and shall be deemed to have taken effect from 1st day of June, 2020.

2. In the Sindh Board of Technical Education Ordinance, 1970, in section 12, after sub-section (1), the following new sub-section shall be inserted:-

“(1-A) The Board shall have the power to grant certificate and diploma to the candidates promoted without examinations due to outbreak of epidemic or pandemic or Emergency declared by the Government:

Provided that the promotion of candidates shall be subject to such Standard Operating Procedures or Policy approved by Government.”.

3. In the Sindh Boards of Intermediate and Secondary Education Ordinance, 1972, in section 11, after sub-section (1), the following new sub-section shall be inserted:-

“(1-A) The Board shall have the power to grant certificate and diploma to the candidates promoted without examinations due to outbreak of epidemic or pandemic or Emergency declared by the Government:

Provided that the promotion of candidates shall be subject to such Standard Operating Procedures or Policy approved by Government.”.
