ELECTIONS (THIRD AMENDMENT) ORDINANCE 2001

SINDH OF DINANCE NOXXIX OF 2001

AN ORDINANCE

to further amend the Sindh Local Government Elections Ordinance, 2000.

WHEREAS, it is expedient to amend the Sindh Local Preamble. Government Elections Ordinance, 2000, in the manner hereinafter appearing;

under the Local Government Elections AND WHEREAS, Order, 2000 (No. 8 of 2000), the Chief Executive of Pakistan has been pleased to empower the Chief Election Commissioner to conduct local government elections in the Provinces;

AND WHEREAS the Provincial Assembly stands dissolved in pursuance of the Proclamation of the fourteenth day of October, 1999, and the Provisional Constitution Order No.1 of 1999;

AND WHEREAS, the Governor of Sindh is satisfied that circumstances exist which render it necessary to take immediate action;

pursuance of the aforesaid NOW, THEREFORE, in Proclamation and the Provisional Constitution Order read with Provisional Constitutional (Amendment) Order No.9 of 1999, and in exercise of all powers enabling him in that behalf, the Governor of Sindh is pleased to make and promulgate the following Ordinance:-

Short title and commencement.

- This Ordinance may be called the Sindh Local Government Elections (Third Amendment) Ordinance, 2001.
 - It shall come into force at once and shall be deemed always (2)to have taken effect from the 4th October, 2000.

Amendment of ection 19 of Sindh Ordinance No. X of added:-2000.

In the Sindh Local Government Elections Ordinance, 2000, in section 19, after full stop at the end the following explanation shall be

"Explanation. For the purpose of this section, a holder of an elective office means a person who has taken oath in accordance with the rules made under this Ordinance. ...
