**THE SINDH LAND REVENUE (ABOLITION) ORDINANCE, 2000.**

**SINDH ORDINANCE NO. III OF 2000.**

AN  
ORDINANCE

to abolish the land revenue in the Province of Sindh.

WHEREAS it is expedient to abolish the land revenue in the Province of Sindh; Preamble.

AND WHEREAS the Provincial Assembly stands suspended in pursuance of the Proclamation of the fourteenth day of October, 1999, and the Provincial Constitution Order No.1 of 1999;

AND WHEREAS the Governor of Sindh is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in pursuance of the aforesaid Proclamation and the Provisional Constitution Order read with Provisional Constitution (Amendment) Order No.9 of 1999, instructions of the Chief Executive and in exercise of all powers enabling, in that behalf, the Governor of Sindh is pleased to make and promulgate the following Ordinance:-

Short title and commencement. 1. (1) This Ordinance may be called the Sindh Land Revenue (Abolition) Ordinance, 2000.

(2) It shall come into force at once.

Definitions 2. (i) "Act" means the Sindh Land Revenue Act, 1967.

(ii) "land revenue" means the land revenue as defined in the Act.

Abolition of revenue. 3. Notwithstanding anything contained in the Act or any other law for the time being in force, no land revenue shall be charged for the year 1999-2000.

ORDINANCE

To do away with land revenue in the province of Sindh.

WHEREAS it is expedient to abolish the land revenue in the Province of Sindh.

ENACTED IN ASSEMBLY

4. Nothing contained in this Ordinance shall be construed to affect the liability of any person to pay the land revenue which became due before Kharif 1999-2000 or the assessment, charge and collection of the land revenue for the period before Kharif, 1999, which shall continue to be assessed, charged and collected under the Act.
