THE SINDH WILD LIFE PROTECTION SECOND (AMENDMENT) ORDINANCE 2001

Sindh Ordinance No. XVIII of 2001.

AN ORDINANCE

to further amend the Sindh Wildlife Protection Ordinance, 1972.

WHEREAS it is expedient to amend the Sindh Wildlife Protection Ordinance, 1972, in the manner hereinafter appearing; Preamble.

AND WHEREAS the Provincial Assembly stands suspended in pursuance of the Proclamation of the fourteenth day of October, 1999, and the Provisional Constitution Order No. 1 of 1999;

AND WHEREAS the Governor of Sindh is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in pursuance of the aforesaid Proclamation and the Provisional Constitution Order read with Provisional Constitution (Amendment) Order No.9 of 1999, and in exercise of all powers enabling him in that behalf, the Governor of Sindh is pleased to make and promulgate the following Ordinance:-

1. (1) This Ordinance may be called the Sindh Wildlife Protection (Second Amendment) Ordinance, 2001.

Short title and commencement.

(2) It shall come into force at once.

2. In the Sindh Wildlife Protection Ordinance, 1972, hereinafter referred to as the said Ordinance, in section 14, in sub-section (3), in the second proviso thereto, the full stop at the end shall be replaced by colon and thereafter the following new proviso shall be added:-

Amendment of section 14 of Sindh Ordinance V of 1972.

“Provided also that this sub-section shall not apply to any activity in a wildlife sanctuary in connection with the exploration or production of oil or gas which is undertaken in accordance with an environmental impact assessment, as defined in the Pakistan Environmental Protection Act, 1997 (Act, XXXIV of 1997).”

3. In the said Ordinance, in section 15, in sub-section (4), in the second proviso thereto, the full stop at the end shall be replaced by colon and thereafter the following new proviso shall be added:-

Amendment of section 15 of Sindh Ordinance No.V of 1972.

“Provided also that this sub-section shall not apply to any activity in a national park in connection with the exploration or production of oil or gas which is undertaken in accordance with an environmental impact assessment, as defined in the Pakistan Environmental Protection Act, 1997 (Act, XXXIV of 1997).”
