4. Special Quotas shall be observed as per the Government of Sindh's rules and policies.
5. A general age relaxation up to "five (05) years" in the upper age limit shall be applicable as per the Sindh Government policy.
6. The number of vacancies may be increased or decreased, and no claim in this regard shall be entertained.
7. Candidates already in Government service should apply through proper channel.
8. Only shortlisted candidates will be called for a **test/interview**.
9. Security clearance / Medical examination will be conducted for selected candidate only.
10. Candidates applying for more than one post must submit a **separate application** for each post.
11. The Secretariat reserves the right to reject any application(s) or cancel the entire recruitment process without assigning any reason. No claim whatsoever shall be entertained in this regard.
